2. UKPR Group Corporate Environmental Policy

2.1. Objective

Concern for the environment is an integral and fundamental part of UKPR Group's corporate business strategy. UKPR Group is committed to sound environmental management practices and the prevention of pollution whilst carrying out its business operations. UKPR Group endeavours to work closely with the relevant statutory bodies to meet all current legislation, regulations and contractual obligations and shall seek to make continuous improvements to reduce its impact on the environment. This policy shall be publicized to all employees, ensuring that they are aware of their responsibilities within it, and to interested parties. UKPR Group monitors the progress of the Policy and reviews the environmental performance yearly.

2.2. In all its activities UKPR Group seeks to:

- conserve and improve the use of energy and raw materials wherever possible
- reduce wastage and recycle materials to the maximum, i.e. paper recycling, can & tin recycling, printer cartridge recycling
- aim for zero waste generation at the source. Materials will be reused and recycled to minimise the need for waste treatment or disposal and to conserve resources
- avoid pollution of air, land and water wherever possible
- improve the working environment
- support the local community in its environmental initiatives
- seek to achieve environmental excellence in all our business operations
- discuss environmental issues regularly at the highest levels of the business
- train and regularly consult employees on good environmental practices
- reduce water usage wherever possible and control wastewater discharge
- liaise with suppliers and customers to facilitate the best possible environmental practices in the manufacturing and installation chain, and promote the recycling of materials
- sustain and protect the local environment
- reduce our energy costs by switching off equipment like computers, printers, photocopiers, and lights when leaving the building. Further within the office environment low emission LED lighting has been installed in all areas during 2022.
- reduce the environmental emissions associated with travel (including employee travel to work, business travel and distribution of goods) by utilising modern communication tools such as email and conference calls to stay in contact with our partners
- Allow working from home to be undertaken when possible for staff who undertake a role whereby such working practices apply to the business need.
- Reduce all environmental impacts arising from our energy consumption as far as is practical, and consistent with the operational needs of our activities. To this extent, UKPR Group has engaged with CDP in their program and will look to obtain scope 2 within their program by engaging with our energy provider into 2023.
